Conditions of Approval:

Commercial and buildings housing over 2 families shall have STATE APPROVED heating plans attached to this application. Residential heating plans, heat loss calculations & specifications for the equipment to be installed shall be submitted with this application.

REQUIREMENTS FOR HVAC PERMIT

The inspection Department desires to process your permit application as quickly as possible.

To accomplish this we need accurate and complete information on the application. Unfortunately incomplete applications cannot be processed and will be held until the missing information is received. The following information is required for plan review.

1. HVAC permit application.
2. Electrical Permit application for equipment installation.
3. For new 1 & 2 family dwellings, submit a detailed plan of the distribution system for forced air or hydronic heating including size and location of the heating and cooling equipment.
4. A sketch to scale, site plan or survey showing the placement of any mechanical equipment located outside of the building. Indicate the location of the equipment and the distance to lot lines.
5. For commercial projects, HVAC plans must be stamped and signed by a design professional.
6. Load calculations maybe requested for heating, cooling and exhaust loads.
7. Correct fees should be submitted with permit application.

FEES

1. Heating, units and wood burning appliances - \$60/unit up to and including 150,000 BTU input BTU units. Additional fee of \$18/ea. 50,000 BTU or fraction thereof.
2. Commercial/Industrial exhaust hoods & exhaust systems - \$125/unit
3. Heating & air conditioning distribution systems - \$1.75/100 Sq. Ft. conditioned area with a \$55 minimum.
4. Air conditioning - \$60/unit up to 3 tons or 36,000BTU's. Additional fee of \$18/ea. Ton or 12,000 BTU's or fraction thereof. \$800.00 maximum/unit.
5. Plan review \$70.
