A detailed description of the event should be listed below and/or attached to this application, including, if applicable, a route for any walk, run or race, tents & specific locations where the event will take place on the property. Unless revoked for cause before expiration, the applicant hereby agrees to comply with all Federal, State and Local laws, resolutions, ordinances, and regulations. A certificate of liability insurance is also required. See Section 349-4 on the back of this application.

§ 349-3 **Exceptions.**

A permit shall not be required for the following:

- A. A funeral procession, Memorial Day Parade, Village- or school-sponsored parades or special events.
- B. Students going to and from school classes or school activities, providing such conduct is under the supervision of school authorities.
- C. Use of the Ice Age Trail.



§ 349-4 **Financial Responsibility.**

**A.**

A certificate of liability insurance in the following amounts must be provided prior to the issuance of the permit:

- (1) One-million-dollar policy for events such as athletic events, fireworks displays and bicycle races;
- (2) Five-hundred-thousand-dollar policy for special activities such as runs, walks, carnivals, circuses, concerts and festivals;
- (3) Three-hundred-thousand-dollar policy for other activities such as parades, trade/car shows, and art and craft shows.

**B.** The Village reserves the right to designate the appropriate level of insurance and, if substantial risk is present, may require additional levels of insurance.
