In accordance with Village of Slinger Code Section 178 - "Amusement Devices".

Registration. The Village requires all property owners or renters shall, register or cause to be register all of their electronic games, billiard tables, juke boxes and pinball machines on location for use. This should be done no later than the first Monday of June so new licenses are ready prior to their expiration on June 30th.

Amusement Licenses run from July 1st to June 30th of the following year. Nothing herein contained shall be construed to authorize the registration of any slot machine or gambling devices not allowed by the State.

Fees. Fees for any applications, petitions, licenses, or permits, shall be as set by the Village Board of the Village of Slinger by a duly enacted Resolution and may be changed from time to time.

Current Fees: \$35/ea.
Arcade License: \$30 (additional fee needed for 8 or more machines)

The Village Clerk requires the registrant to submit the information as may be necessary to identify the electronic games, jukeboxes, billiard tables, and pinball machines so registered, and will issue to the registrant an appropriate permit. This permit must be kept on the premises and available for inspection at any time. Keep

in mind any person, firm, corporation or LLC must be current in the payment of taxes, personal or real, utilities and/or any other payments due the Village or no license will be given.

Seizure. The Village President, Chief of Police or any police officer may seize or cause to be seized any electronic game, billiard table, jukebox or pinball machine upon which is not listed on the amusement license.

Please return the application **NO LATER THAN May 26, 2022**. Applications will be reviewed by the Village Board at their meeting in June (currently they meet the 3rd Monday of the month). Licenses will be prepared and ready for owners to pick up before July 1, 2023. All fees must be paid to the Village of Slinger prior to any licenses being issued.
